#### 1. Call to order

### 6. Department Reports

- Fire Department – New Truck vs Used Truck (Attached as Schedule "A")

Fire Chief Chetwynd reported that Fire Truck # 132 was inspected this morning and all is good.

The Town Clerk/Treasurer informed the Committee that the Municipality of the District of Shelburne has their Council Meeting today so we can hope to hear something from them in the next day or two regarding the information provided to them from Fire Chief Chetwynd re: the purchase of a new vs used Fire Truck.

The Fire Department/First Responders are trying a new texting service that promises to be more economical than the current service. The new service is called IM Responding and it offers the first two months free of charge. If things work well the Town stands to save \$400.00 to \$500.00 per year. This new service offers more options than the old service.

- Public Works (Attached as Schedule "B")

Mayor Harding asked for more details regarding the options for the ditching project on John Street.

The Working Streets Foreman explained that Harlow's Construction quote lists two steps to the project which are as follows:

Step 1 – On the right hand side where a small ditch was constructed last year, excavate a trench and install stone and perforated pipe approximately 2' to 2.5' deep that would pick up ground water and take it down the hill to the ditch on the sewage plant access road. This ditch may lower the ground water and prevent it from breaking out through the pavement. Upgrade the ditching on the left side and expand on the width and depth of the ditch. This will involve culvert access changes etc.

Step 2 – If the street continues to have breakout of water through the pavement because of where the water supply may be originally from than we may have to remove the asphalt and materials from underneath and install a clear stone drainage mat that would tie into the side drainage.

Step one has to be done anyway and the decision to do Step two cannot be made until step one has been completed.

The table from the DD Mann that was donated by Bob and Glenna Redding to the Town of Lockeport is currently stored at Crescent Beach Centre. Everyone was asked to give it some thought over the winter as to where this table could go. The Working Streets Foreman thinks it is fine where it is for the winter months.

- Joel D'Entremont - MPAL Report — Physical Activity Strategy (Attached as Schedule "C")

Joel presented his power point presentation and reviewed the history of the Physical Activity Strategy. Joel recommended that Council adopt the Strategy as presented. The following motion was made:
